### POTTER COUNTY COMMISSIONERS MEETING

April 3, 2025

**CALL TO ORDER** Commissioner Heimel called the meeting to order at 11:04 a.m.

#### **GUESTS**

Issac Musser, Potter County Human Services Children and Youth Services Director, joined the board for the Proclamation of Child Abuse Awareness and Prevention Month. He told the public the most important thing you can do to help prevent child abuse is “if you see something, say something”. He noted that since the beginning of 2025 there have been 74 abuse or neglect cases reported, some of which move forward into a full investigation.

Chuck Strodoski from the consulting firm, YSM Landscape Architects, joined the meeting via phone to conduct opening of bids for the Market Village site work. He informed the board that while there were no bids received, three contractors had prepared portions of a bid on the portal but failed to submit their proposals. **COMMISSIONERS' REPORTS**

Commissioner Heimel reported that the County Commissioners Assn. of Pa. (CCAP) has chosen the underfunding of county 911 emergency communications expenses as its top legislative priority for 2025, due to the burden it places on county taxpayers. He noted that rural counties are particularly hard-hit, since the infrastructure costs are similar while rural tax bases are much smaller. CCAP is proposing that

the legislature approve a 25-cent increase in the monthly surcharge on phone bills to provide additional reimbursement to counties.

Commissioner Rossman informed the public of the unfortunate action taken by the Tioga County Commissioners attempting to decertify the Visit Potter Tioga Association..



Abuse Awareness for its valuable service and continued efforts to empower youth with a foundation of success for a lifetime.


