March 06, 2025

CALL TO ORDER Commissioner Paul Heimel called the meeting to order at 11:02 a.m.

PUBLIC COMMENT

GUESTS

Northcentral Pa. Regional Planning and Development Commission Executive Director Jim Chorney provided an overview of the agency's activities and initiatives. He requested the commissioners' engagement in regional community and economic development strategic planning, including high-priority and timely matters such as a multi-county approach to ensure access to health care services and the effort to prevent the closure of Penn State University's branch campus in DuBois. Director Chorney also updated the board on revisions to North Central's community capacity services and encouraged public engagement in the agency's transportation planning and advocacy activities.

Potter County GIS/Planning/Community Development Director Will Hunt presented an update on the Market Village project. Site work bids will be accepted until 11 am on Friday, March 28. There is much excitement behind this project, which has been in the works since 2018. Site development funds were acquired through a state Community Conservation Partnership Program grant. Phase 1 is construction of a walkway, parking, utilities, benches and other improvement. Phase 2, if approved, would consist of semi-permanent rental spaces where retail businesses could be set up on a temporary basis to market their products and potentially relocate to another location in the business district. Director Hunt said the Market Village concept is part of the broader Revitalize Potter County community and economic development initiative.

Commissioner Rossman brought to light that there is an energy capacity shortage across Pennsylvania, which is causing businesses not to be able to move into some areas. The topic is on the agenda of a County Commissioners Assn. of Pa. Community and Economic Development Committee meeting which he will be attending.

Commissioner Heimel provided an update on the America250 initiatives, celebrating the anniversary of the nation's founding. Potter County Historical Society and the Daughters of the American Revolution are spearheading the county's engagement. The observance concludes in July 2026. Activities which are already planned or in the works include local involvement in Bells Across Pa., Liberty Tree plantings, youth engagement, Revolutionary War and Civil War veterans memorials, and others. He encouraged the public to become engaged as opportunities arise.


