CALL TO ORDER Commissioner Nancy Grupp called the meeting to order at 11:00 a.m.

PUBLIC COMMENT District Judge Bryan Phelps inquired about the recent hiring of the Human Resource Manager position. They further clarified that the individual currently performing Human Resource duties had completed both County-funded and self-funded training. These trainings were undertaken prior to the formal creation of the Human Resource Manager position and were intended to support the individual's responsibilities in her then-current role.




