**ORDER AND DISCLOSURE**

AND NOW, this 28<sup>th</sup> day of May 2026 the Court hereby issues this Order to advise any person who is a party to any proceeding within Potter County involving the District Attorney's office that the Court has made a Complaint to the Disciplinary Board against District Attorney Andy Watson. This Disclosure is made pursuant to Canon 2.7, Responsibility to Decide, Comment (3) which provides: *A judge should disclose on the record information that the judge believes the parties or their lawyers might reasonably consider relevant to a possible motion for disqualification or recusal even if the judge believes there is no proper basis for disqualification or recusal.*

The timing of this Disclosure is made pursuant to Panel Advice of May 8, 2026, from the Judicial Ethics Advisory Board to the Judge which provides: *Thus, once the Disciplinary Board has publicly charged/announced disciplinary action against a member of the bar, a judge should disclose their involvement in that attorney's disciplinary process.* The public filing of the Petition for Discipline against the District Attorney has now occurred so disclosure is warranted. The filing can be viewed on the Board's website.



**ORDER**

AND NOW, this 2<sup>nd</sup> day of June 2026 the District Attorney has filed for subpoenas containing personal or confidential information regarding individuals who were under investigation. These filings were prior to 2023. Much of the information contained within the subpoenas is private and/or confidential and should not be disclosed to anyone except the person who is the subject of the inquiry.

Accordingly, should any person request to review a subpoena which contains such information the same will only be released to the person who the subpoena pertains to. Otherwise, any request for subpoenas dealing with other persons shall be reviewed by the Clerk of Courts and the confidential/personal information shall be redacted.

The subpoenas shall remain sealed and not subject to public viewing except as aforesaid. The Clerk of Courts, Ashley Gledhill shall oversee the administration of this Order.
