COMMISSIONERS' REPORTS

Commissioner Grupp informed the public that Federal Emergency Management Agency personnel are now on the ground in the flood zone and for the next three weeks will be going door to door to verify forms and begin distributing relief funds. She noted that \$1.3 million has been approved so far for individuals affected, which does not include funds for municipalities or PennDOT. FEMA assistance can be requested by phone, through a mobile office, or via the agency website. She also announced that Northcentral Pa. Regional Planning and Development Commission is holding a public meeting on Oct. 2 for input on highway safety projects in the region.

Commissioner Heimel noted that the highway safety meeting is a proper forum to advocate or traffic safety measures at the Rt. 6/Rt. 872 intersection in east Coudersport. He also announced that Potter County has been approved to receive a \$90,000 state grant to support indigent defense. He explained that the public defender's caseload is currently very high. Funds can be used for conflict counsel, paralegal, investigator and/or social worker to alleviate some of the caseload.

Commissioner Rossman reported that he has met with FEMA officials who have been conducting damage assessments in flood-affected communities. He emphasized the importance of these assessments in ensuring proper aid distribution and thanked FEMA for its response. Additionally, he announced that an open house will be held at the new Potter County Veterans Services Office on Sept. 28.

RESOLUTION # 10 OF 2024

RESOLUTION OF THE BOARD OF COMMISSIONERS OF POTTER COUNTY,
PENNSYLVANIA TO ADOPT AN AMENDMENT TO THE ARTICLES OF INCORPORATION
FOR THE AREA TRANSPORTATION AUTHORITY OF NORTH CENTRAL PENNSYLVANIA
TO EXTEND ITS TERM OF EXISTENCE FOR A PERIOD NOT TO EXCEED 50 YEARS
FROM THE DATE OF THE APPROVAL OF THE ARTICLES OF AMENDMENT AND TO
TAKE ANY AND ALL OTHER ACTIONS RELATED THERETO.

WHEREAS, the Area Transportation Authority of North Central Pennsylvania (hereinafter "Authority") is a body corporate and politic, incorporated by the Boards of Cameron County, Clearfield County, Elk County, Jefferson County, McKean County and Potter County, and is existing under and is governed by the provisions of the Municipalities Authorities Act, 53 Pa.C.S.A. § 5601 et seq., which codifies and amends the Municipalities Authorities Act of 1945, as amended and supplemented (hereinafter the "Act"); and

WHEREAS, by this duly adopted Resolution dated <u>August 21, 2024</u> the Authority proposes to amend its Articles of Incorporation to add a provision to increase its existence to a date not exceeding fifty (50) years from the date of the approval of the Articles of Amendment pursuant to the powers vested in it by the Act; and

WHEREAS, the Authority thereafter confirms that the County Boards consent to this amendment to its Articles of Incorporation by the Boards of Cameron County, Clearfield County, Elk County, Jefferson County, McKean County and Potter County, Pennsylvania for adoption in accordance with the applicable provisions of the Act; and

NOW THEREFORE BE IT RESOLVED that:

- 1. The Board of Commissioners of Potter County, Pennsylvania hereby adopts this resolution proposed by the Authority to amend its Articles of Incorporation to add a provision to extend its existence to a date not to exceed a period of 50 years from the date of Authority's approval of the Articles of Incorporation.
 - 2. This Resolution shall be effective immediately.
