COMMISSIONERS' REPORTS

Commissioner Hayman addressed a question that was raised at a previous meeting on the projected cost of housing females at the county jail. Total increased cost to the county in 2022, taking into account staffing, food, supplies, building modifications and operation changes, would have been in excess of \$150,555, over and above payments made to other jails to house Potter County's female inmates and detainees.

Commissioner Heimel discussed ongoing efforts to engage Potter County in the Rural Partners Network programs operated by the U.S. Dept. of Agriculture and other federal agencies in support of community and economic development.

Commissioner Grupp shared information on the state Property Tax and Rent Rebate program for those 65 and older. Application deadline is June 30. Assistance in filling out applications is available at senior centers in Ulysses, Feb. 15; Galeton, Feb. 16; Oswayo Valley, Feb. 22; Coudersport, March 1 (11 am to 1 pm); and Austin, March 1 (11 am to 1 pm) and Coudersport (1 pm to 3 pm). Forms are also available online at revenue.pa.gov. Commissioner Grupp also advised the public that Potter County Human Services has sent letters detailing upcoming changes in eligibility for the Supplemental Nutrition Assistance Program.

RESOLUTION #_____ OF 2023 POTTER COUNTY, PENNSYLVANIA

A resolution of Potter County, Commonwealth of Pennsylvania, establishing a schedule of fees for the Potter County Subdivision and Land Development Ordinance.

WHEREAS, the Potter County Board of Commissioners enacted a new, updated Subdivision and Land Development Ordinance January 12, 2023 to take effect 30 days thereafter; and

WHEREAS, Section 302 of said ordinance, as further authorized by the Pennsylvania Municipalities Planning Code, provides for establishment, by resolution of the Potter County Board of Commissioners, of a schedule of fees to be paid accompanying applications for subdivisions and land developments;

NOW, THEREFORE, BE IT RESOLVED by the Potter County Board of Commissioners that a schedule of subdivision and land development application and review fees attached hereto is hereby established and shall take effect on the effective date of the new, updated Potter County Subdivision and Land Development Ordinance.
