#### **COMMISSIONERS' REPORTS**

Commissioner Heimel reported on meetings and conversations he has held with members of the State House and State Senate as interim chair of the Pa. State Land Tax Fairness Coalition. He said that a bill now pending in the legislature would increase state payments-in-lieu-of-taxes (PILT) on tax-exempt state forest park and game lands, which comprise more than 45 percent of the county's total real estate.

Commissioner Hayman announced that the Potter County Education Council is conducting a winter clothing and diaper drive through Dec. 7. More information is available at the PCEC office on Water Street in Coudersport, where donations can be made.

Commissioner Grupp noted that all five of the food banks in Potter County are in need of donations, particularly as they plan to serve as many needy families as possible during the holiday season.
