COMMISSIONERS' REPORTS

Commissioner Heimel reported on his meeting with two program directors from U.S. Justice Department's Jails and Justice Support Center. The agency provides free reviews of jail operations to address potential risks the county and recommend improvements in mental health and addiction treatment services, leadership, culture and morale, health care, security, and safety. Members of the Potter County Jail Board will consider a proposal to engage with the center during their Aug. 2 meeting.

Commissioner Rossman congratulated Potter County Planning/Community Development/GIS Services Director Will Hunt for his selection as the Pennsylvania Wilds Planning Team Member of the Year. the honor recognizes his leadership in advocating for and supporting outdoor recreation, as well as preservation of the region's rural character. This includes his management of the county department. leadership of a countywide ATV Task Force, and revisions to the Subdivision and Land Development Ordinance.

Commissioner Grupp encouraged the public to attend the Potter County Fair, which remains the only county fair in Pennsylvania with no entry or parking fees. She also noted replacement of the fair's Senior Day with a Senior Expo in Coudersport which debuted this year with a good turnout.
